The Wisconsin Farmland Protection Partnership is proud to reflect on a year of growth, collaboration, and milestones that are shaping the future of Wisconsin agriculture.

Together with our partners, we've made exciting strides in permanently protecting farmland, engaging communities, and advocating for the agricultural landscapes that sustain us all.

First Easement Secured: A Historic Moment

2024 marked a major milestone: the successful closing of our first agricultural conservation easement through the partnership! **Tall Pines Conservancy** permanently protected Cozy Nook **Farm**, a sixth-generation dairy and vegetable operation in Waukesha County. Thanks to the **Oberhaus family's** dedication, this beloved farm will remain an agricultural asset for generations. Cozy Nook will continue welcoming the public with farm tours and educational events that keep the community connected to their food and farming heritage.

Groundswell Conservancy and the **Town of Dunn** have also worked diligently to protect two farms since the beginning of 2025.

Celebrating Success in Evansville

Last fall, we gathered in Evansville, WI for a joyful celebration of farmland protection. Hosted at the Bjugstad Family Farm—protected in partnership with the Wisconsin Department of Natural Resources (WI DNR) and Groundswell Conservancy—the event brought community members together to honor the land's legacy. Senator Mark Spreitzer offered inspiring remarks on the importance of safeguarding Wisconsin's farmland for future generations.

With storytelling at the heart of our mission, we produced the first-ever **Farmland Protection Profile**, chronicling the **Monis Family's** farming journey and vision for the future. Hands-On Learning Across Wisconsin

Our fieldwork blossomed last year! In partnership with Sauk County, the Savanna Institute, the Department of Agriculture, Trade and Consumer Protection, and the Natural Resources Conservation Service, we hosted two field days focused on soil

health, agroforestry, and innovative grazing systems. Our popular webinar series, **Protecting Local Farmland by Inch and Acre** (Season 2), featured three sessions tackling soil health, landowner engagement, and NRCS funding strategies.

Demonstration Farm: Conservation in Practice

The Savanna Institute established a demonstration farm at South Farm in Spring Green, showcasing silvopasture and forage establishment. The site will serve as an educational touchpoint for soil health practices and implementation. Savanna Institute is also conducting soil health research at the site to explore metrics of soil function before and after implementation. Stay tuned for more!



Partners in Protection

In 2024, members of the Partnership contributed significant time, expertise, and financial resources to realizing project goals. Partners contributed \$2.7 million in financial assistance for easement acquisition and land management activities. This monumental contribution was leveraged by \$489,000 in technical assistance towards activities such as supporting outreach and education for farmland protection and soil health.

To date, partner efforts have:

- Permanently protected
 579 acres of Wisconsin farmland forever.
- Created a statewide net economic impact of \$10,825,681.
- Engaged 2,625 individuals in farmland protection education and outreach.
- Helped implement 208.5 acres of cover crops and silvopasture practices.

Land Management on the Landscape

Kyle Zwieg of Zwieg's Maple Acres in Ixonia, Wisconsin and received RCPP

and received RCPP
land management cost-share
for cover crop implementation.
The funding allowed Zwieg to
plant 180 acres of cover crops
following the wheat, soybean, and
corn harvests. Zwieg shared on
the significance of implementing
cover crops as a part of his land

management strategy,
"High quality cover
crops benefit the
land and our crop

production immensely but require a significant amount of money to attempt to establish. RCPP money helps offset risk with weather and other factors to help make it possible for cover cropping to be adopted on a large number of acres."

What's Underway in 2025

Looking at the progress already underway in 2025, the partnership is excited to build on this year's momentum with more easement closings, outreach, and education. Here's what's on the horizon:

- Two **easements** have already closed in early 2025, with six more under obligation and expected to close by year-end.
- Outreach efforts for **land management cost-share** reached 300 eligible landowners within the partnership geography.
- We're planning another **Farmland Protection Profile**, diving deeper into the values and long-term planning that make conservation easements successful.
- We are hosting two **Dig into Soil Health Field Days** in partnership with Tall Pines Conservancy and Groundswell Conservancy.
- Four new **webinars** will explore farmland protection as a tool for land access, broadening our impact and reach.
